SGL Carbon is a technology-based company and global leader in the development and production of carbon-based solutions. Its high-quality materials and products made of specialty graphite, carbon fibres and composites are used in industries that determine a sustainable future: the chemical sector and industrial applications, automotive, aerospace, semiconductor technology, solar and wind energy, LED as well as in the production of lithium-ion batteries, fuel cells and other energy storage systems.

SGL Carbon pursues for its activities a balance between economic, social and environmental aspects. To reduce our footprint on the environment and to address climate change, we strive for a minimal impact on the environment and the most ecological use of natural resources in all our products and processes. Furthermore, we strive to create a safe and healthy workplace for our employees and stakeholders. Due to the importance of occupational health and safety, we have implemented a separate Global Health and Safety Policy applicable to the entire Group.

SGL Carbon has implemented a Group-wide ESG governance structure whose highest decision-making body is the ESG Steering Committee that meets regularly under the leadership of the Board of Management to implement and further develop the Group-wide ESG measures and objectives.

As sustainability is an integral part of its values, SGL Carbon has a Group-wide strategy with targets and initiatives to avoid, reduce or mitigate environmental and social impacts at its sites. As part of our Group-wide strategy, we are also committed to monitoring and regularly reporting on our environmental performance against key performance indicators. Our Group-wide environmental strategy covers the following environmental performance areas:

- Energy consumption (incl. electricity, natural gas and other fossil fuels)
- Greenhouse gas (GHG) emissions
- Waste (hazardous and non-hazardous)
- Water consumption
- Recycling and Circular Economy
- Air pollution
- Biodiversity
