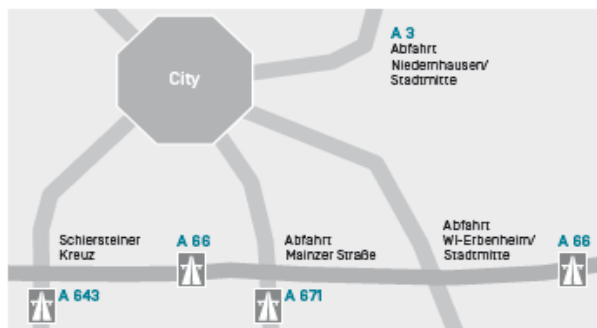


How to get to the Annual General Meeting of SGL Carbon SE

Parking spaces

At the Annual General Meeting 2019, reserved parking spaces will be available to our shareholders and guests free of charge solely in the car park of the RheinMain CongressCenter ("RMCC"), Friedrich-Ebert-Allee 1, 65189 Wiesbaden, Germany, from 8:00 a.m. to 6:00 p.m.

A free shuttle service between the RheinMain CongressCenter and the Kurhaus Wiesbaden will be available from 8.30 a.m. to 6.00 p.m. This shuttle service runs every 15 minutes; the departure is directly in front of the RMCC at the designated pick-up point for the shuttle service.

Please note that we were unable to reserve parking spaces for our shareholders and guests in the Theater car park or the Kurhaus / Casino car park.



Public transport

The journey to Wiesbaden by public transport is possible by the long-distance trains of the Deutsche Bahn AG or by local public transport like the S-Bahn lines S1, S8 and S9 to Wiesbaden main station and local buslines.

From the Wiesbaden main station you can take a taxi, the local Wiesbadener Verkehrsbetriebe buses (bus lines 1 or 8 in the direction of the Kurhaus/Theater) or walk to the Kurhaus Wiesbaden. The journey takes about 10 minutes.

If you travel by local public transport, we will reimburse the costs.

Security check
